

COMMUNITY DEMANDS:

1. **Full retesting of the entire Shipyard and adjacent areas, including parcels already transferred. – not just scanning**

Retesting must include the entire original shipyard site, parcels that have already been transferred, and adjacent areas such as Mariner's Village. Tetra Tech worked in many areas of the Shipyard, including Parcel A where people now live. Merely scanning is not enough. Comprehensive core sampling must be done.

2. **Community oversight of testing and cleanup**

Since the Hunters Point Naval Shipyard Superfund Site Remediation Advisory Board was disbanded, the testing and cleanup process moving forward must include independent community oversight. This component must also be without conflict of interest. Therefore, no one affiliated with government agencies or anyone who received financial benefit from the Lennar project should serve in this role.

3. **Oppose the Navy's proposed "remedy" for Parcel E/E2**

USEPA and Navy plan to leave radioactive and hazardous wastes buried at the waterfront at the Shipyard – ignoring the fact that rising sea levels will inundate and flood the contamination, spreading it into the Bay and community.

4. **No more homes should be built at the Shipyard Site – and no one should live there**

It is a fact that this Superfund site is one of the most contaminated sites in the nation. The discovery of highly radioactive equipment next to homes is proof that the extent of the contamination problem is enormous. No one should live next to or on top of radioactive and toxic waste.

5. **The City and other agencies must protect people, not corporate developers who want to gentrify Bayview Hunters Point – hold government officials accountable and eliminate conflicts of interest**

The Board of Supervisors must rescind the City contract with Lennar for them to pay San Francisco Department of Public Health to work on this project. The current SFDPH staff engaged at Hunters Point and other land development sites should be removed from these areas due to their bias. Our government officials work for the people, not giant corporate developer Lennar/Five Points.

BAYVIEW HUNTERS POINT COMMUNITY DEMANDS A FULL CLEANUP OF TOXIC AND RADIOACTIVE WASTE AT THE HUNTERS POINT SHIPYARD SUPERFUND SITE & ADJACENT AREAS

To achieve a comprehensive cleanup that protects the health and environment of our community, we call on our elected officials and government agencies to support the following demands:

- 1. A full retesting of the entire Shipyard and adjacent areas, including parcels already transferred**
Retesting must include the entire original shipyard site, parcels that have already been transferred, and adjacent areas such as Mariner's Village. Tetra Tech worked in many areas of the Shipyard, including Parcel A where people now live. Merely scanning is not enough. Comprehensive core sampling for toxic and radioactive contamination must be done.
- 2. Community oversight of testing and cleanup**

USEPA and the Navy plan to leave radioactive and hazardous waste buried at the waterfront – ignoring the fact that rising sea levels will inundate and flood the contamination, spreading it into the Bay and community.
- 4. No more homes should be built at the Shipyard Site**
This Superfund site is one of the most contaminated sites in the nation. The fact that a chemical fire burned for over three months underground is proof of the the extent of the contamination.
- 5. The City and other agencies must protect people, not corporate developers**
The City of San Francisco must oppose the gentrification of Bayview Hunters Point and hold government officials with conflicts of interest accountable. The Board of Supervisors must rescind the City contract with Lennar for them to pay San Francisco Department of Public Health to work on this project. The current SFDPH staff engaged at Hunters Point and other land development sites should be removed from these areas due to their bias. Our government officials work for the people, not giant corporate developer Lennar/FivePoint.
- 6. Provide funds for fully-equipped mobile medical units and medical experts chosen by the the Bayview Hunters Point community**
The city and other agencies must provide funding for mobile medical units in order to conduct medical and epidemiological examinations of Bayview Hunters Point residents. These agencies also need to fund medical and scientific experts, chosen by the Bayview Hunters Point community, to conduct these examinations.
- 7. Government agencies must conduct monthly public meetings about the testing and cleanup**
From this point forward, government agencies need to effectively inform and engage the people of Bayview Hunters Point by holding a monthly public meeting.
