Introduction

The archival and manuscript holdings of the Hoover Institution on War, Revolution and Peace consist of over 3,700 collections, occupy some 15,000 linear feet of shelving, and cover the field of 20th century political, social, and economic history for most geographical areas, including North America, Eastern Europe and Russia, Western Europe, East and Southeast Asia, the Middle East, Africa, and Latin America. Included are records of organizations, papers of individuals, unpublished memoirs and histories, collections of ephemera, and audiovisual materials. They document international relations, major political ideologies, war relief, world migrations, revolutionary upheavals, military and diplomatic history, and activities of governments, international bodies, and resistance movements throughout the 20th century.

Materials may be examined in the reading room of the Hoover Institution by persons who present required identification, complete the registration form, and adhere to rules regarding use. Archival and manuscript materials are not available through inter-library loan. Reference service is provided for both reading room users as well as persons writing for information, and a limited number of photocopies may be purchased in accordance with our reproduction price list and policy statement (available upon request). For extensive searches involving detailed research or selection of documents for copying, names of qualified persons who do research for a fee can be furnished.

Reading room hours are 8:15 a.m. to 12:00 noon and 1:00 p.m. to 4:45 p.m. Monday through Friday. Principal administrators are W. Glenn Campbell, Director; Richard F. Staar, Associate Director for Library Operations; and Milorad M. Drachkovitch, Archivist. Inquiries should be addressed to the Archivist.
