Last woman out. Freda Frost (or "Frost," in some records) seems to have been the last woman held at Eastern State. She served the first 13 years of her 24-year murder sentence inside this building.



B-2550: Kate Hogan was sentenced five times to Eastern State Penitentiary, at least four times for larceny (non-violent theft). More than half of the women sentenced to Eastern State were convicted of this crime.



B-3018: In 1904, Catherine Danz was convicted of murdering her husband with poison. Initially sentenced to death by hanging, her sentence was changed to life imprisonment. Mrs. Danz maintained her innocence, claiming that "she had bought powders...and administered them to her husband for the purpose of curing the drink habit." She received a full pardon and was released from Eastern State in 1911.



B-3094: Sadie Smith (alias Sadie Schowell) was a career shoplifter. She was sentenced to one year and six months at Eastern State for larceny.



B-2661: Rosa Pilnick and her husband (B-2662) were convicted of "Keeping a Bawdy or Disorderly House" in 1905. The couple was connected with at least ten houses of prostitution. They were previously convicted of "harboring a minor for immoral purposes."



C-1450: Lucy Stewart, her husband George, and another man were tried for the murder of a taxi driver in 1921. During the course of the trial George Stewart took full responsibility for the killing, trying to absolve his wife. His efforts were unsuccessful; Lucy Stewart received 9 to 15 years in prison. Her husband received the death penalty.



B-2731: Sarah Hines and two men were found with \$500 in counterfeit currency and "molds and materials for coining bogus money" in 1905. A federal court sentenced her to serve two years at Eastern State Penitentiary.



B-3026 and B-3027: According to their victim, Thomas Zell, Edna Hartz (left) and Mary Davis (right) allowed him to drink beer freely during a carriage ride until he became dizzy. They then "dealt [him] a terrific blow over the head with a beer bottle.... He fell to the ground unconscious," and the women stole \$50 from him. Edna Hartz received one year for "Robbery, Felonious Assault and Battery, and Administering Stupefying Drugs." Mary Davis received two years for robbery.



C-250: Eva Cole, a chamber maid in Dauphin County, was sentenced to one year for felonious assault.



B-3270: Emma Walker was convicted of larceny in 1906. She was sentenced to one year, six months. She was 23 years old.



B-2563: Mary Dunn was sentenced to 15 years for murdering her sister-in-law during a street brawl. The sentence was severe: a typical murder sentence for a woman at Eastern State was ten years or fewer.



C-721: Lillian Thomas, sentenced to one year, three months in Dauphin County for receiving stolen goods.



B-2637: Elizabeth Ashmead was convicted in 1905 for performing abortions. She was later sent to Kansas State Penitentiary where she was imprisoned for another five years for "Using the Mails...for the Purpose of Arranging for Illegal Operations."

Photos from the early 20th Century: most of Eastern State's female prisoners were never photographed. The first female prisoners arrived in 1831 but mug shots were not introduced until roughly 1904.

Photos of women convicted between 1904-1906 are taken from Eastern State Penitentiary's mug shot book. All other photos are taken from Intake ("Bertillon") Cards.
